

**HARYANA GOVT: GAZ., (EXTRA) JULY 31, 2001
(SRVN 9, 1923 SAKA)**

Notification

The 31st July, 2001 No.S/O.103/C.A.29/1986/S.5 and 7/2001. – Whereas, it is necessary and expedient to take immediate steps under Sections 5 and 7 of the Environment (Protection) Act, 1986 (29 of 1986) and rule 4 of the Environment (Protection) Rules, 1986, to maintain ecological balance in the State of Haryana to prevent environmental degradation and avoid traffic and human health hazards.

And whereas the State Government has already taken a decision to maintain ecological balance keeping in view the industrial development and also to maintain the quality of environment and to avoid health hazard for the residents of the area.

Now, therefore, in exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) read with Government of India, Ministry of Environment and Forests, Department of Environment, Forests and Wildlife, notification No.S.O.152(E) dated the 10th February, 1988, and in (Protection) Rules, 1986 the Governor of Haryana hereby directs the operators of Hot Mix Plant in the State of Haryana to follow the following siting criteria norms for establishing the Hot Mix Plant to the State.

Norms for Siting of Hot Mix Plants

1. No plant is allowed to be set up within Municipal Limit/ Urbanisable Zone of the Draft Development Plan/ Development Plan of Town and Country Planning Department, Haryana.
2. Minimum distance from boundary of Municipal Limit/ Urbanisable Zone of the Draft Development Plan/ Development Plan shall be 2 Kilometers.
3. Minimum distance from revenue phirni (lal dora wherever there is no village phirni) shall be 1 Kilometer
4. Minimum distance from the nearest National Highway shall be 1.5 Kilometers.
5. Minimum distance from the nearest State Highway shall be 1 Kilometer
6. Minimum distance from the nearest Major District Road and Other Roads shall be 500 meter.
7. Minimum distance from sensitive places like Hospital, Tourist Spots, Lakes, National Monuments and Bird Sanctuaries shall be 2 Kilometers.

8. Minimum land required for each unit shall be 2 acres.
9. In future, Hot Mix Plant with latest technology of Pollution Control Measures having Fabric Filter with reverse air cleaner based on the principle of Reverse Air Cleaning or Dry dust collector (Multicyclone) with multiple wet scrubber shall only be allowed. Elevators at loading section shall be fully covered.
10. There should be buffer green of at least 30 meters wide between two plants and;
11. Emission Standards required to be achieved: Suspended Particulate Matter (milligram/Normal Cubic Meter)

Note:-

1. Any other emission standards prescribed by Ministry of Environment and Forests, Government of India/ Central Pollution Control Board/ Haryana State Pollution Control Board in future shall also be applicable.
2. These siting criteria shall not be applicable for establishing the Hot Mix Plants directed to be shifted under the orders of the Hon' able Supreme Court of India. Those will be allowed to be set up in the identified zones Only.
3. These siting criteria shall not be applicable for establishing the Hot Mix Plants in identified Hot Mix Plant Zones created in the State viz Ferozpur Kalan in district Faridabad and Silana in district Jhajjar.
4. Preferably the Hot Mix Plants shall be located nearer to the stone crushing Zone so as to avoid traffic hazard and vehicular pollution. These shall be located in one row and there shall be located in one row and there shall not be more than 10 plants at one place.

No. 9/2/97-Env.-II - Whereas as per Haryana Government Environment Department notification No. S.O. 103/C.A./29/1986/S.S. and 7/2001, dated the 31st July, 2001, direction were given for establishing the Hot Mix Plants in the State;

And whereas the State Government is of the Opinion that it is necessary and expedient to make amendment in the Haryana Government, Environment Department notification No. S.O. 103/C.A. 29/1986/S.S. and 7/2001 dated the 31st July, 2001;

Now, therefore, in exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986 (Act 29 of 1986), read with Government of India, Ministry of Environment and Forests, Department of Environment, Forests and Wildlife, notification No. S.O. 152 (E), dated the 10th February, 1988 and in pursuance of the provisions of Section of the said Act and Rule 4 of the Environment (Protection) Rules, 1986 and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following amendment in the Haryana Government, Environment Department notification No. S.O. 103/C.A. 29/1986/S.S. and 7/2001, namely;

Amendment

In the Haryana Government, Environment Department, notification No. S.O. 103/C.A. 29/1986/S.S. and 7/2001 dated the 31st July, 2001, under heading "Norms for siting of Hot Mix Plants":-

(a) **In clause (iv) -**

(i) for sign";" the sign ";" shall be substituted:

(ii) the following provisos shall be added, namely:

"Provided that where the Hot Mix Plants are established temporarily and then shifted elsewhere minimum distance from the nearest National High Way shall be 1.00 Kilometers:

Provided further that the first proviso shall not be applicable to the sites where Hot Mix Plants are established in a cluster."-

(b) **In clause (iv)-**

(i) for sign “;” the sign “;” shall be substituted:

(ii) the following provisos shall be added, namely:-

“Provided that where the Hot Mix Plants are established temporarily and then shifted elsewhere minimum distance from the nearest Major District Road and Other Roads shall be 100 meters.

Provided further that the first proviso shall not be applicable to the sites where Hot Mix Plants are established in cluster.”
