### Office Order

Whereas based upon the directions issued by CPCB vide its letter no. B-29012/ESS (CPA)/2015-16/8526 dated 07.03.2016 to all the State Pollution Control Boards u/s 18(1)(b) of Water Act, 1974 and Air Act, 1981 to adopt the revised criteria of categorization of industrial sectors as per final report on revised classification of industrial sectors under Red, Orange, Green and White categories, a consolidated list of industrial sectors and projects under different categories, was issued vide Head Office order Endst. No. HSPCB/2018/517-544 dated 26.02.2018 for the purpose of consent management under Water Act, 1974 and Air Act, 1981;

Whereas the building and construction project having built-up area of only more than 20,000 sq. m, has been categorized under Red and Orange category based upon quantity of waste water generation from these projects as under:-

1. Building and construction project more than 20,000 sq. m built up area having waste water generation more than 100 KLD under Red category.
2. Building and construction projects more than 20,000 sq. m built up area having quantity of waste water generation 10 KLD to 100 KLD under Orange Category.

Whereas the building and construction project having built-up area less than 20,000 Sq. meter has not been defined under any category. However, the categorization is based upon the quantity and quality of effluent generated from the projects/industrial sectors and area of projects does not have any effect on generation of effluent or other pollutants.

Whereas the matter regarding non-coverage of the building and construction projects having area less than 20,000 Sq. meter under any category, has been examined and discussed with the officers of the Board in Head Office and it has been decided that the criteria of built-up area mentioned in the building and construction projects under Red and Orange category, be omitted for more clarity regarding categorization of these projects.

Therefore in view of above, the categorization of building and construction projects is hereby amended and clarified as under:-

1. Building and construction projects having waste water generation more than 100 KLD, under Red category irrespective of their built-up area.
2. Building and construction projects having quantity of waste water generation 10 KLD to 100 KLD, under Orange Category irrespective of their built-up area.

It is further ordered that inspection of building and construction projects other than covered under Red category and Orange Category as mentioned above, needs to be carried out only with the prior permission of the Head Office.

This order shall come into force with immediate effect.
