AMENDMENT IN SERVICE REGULATIONS, 2021 REGARDING QUALIFICATION FOR DIRECT RECRUITMENT TO THE POST OF LABORATORY ATTENDANT IN THE BOARD.

Amendment in Service Regulations, 2021 regarding qualification for direct recruitment to the post of Laboratory Attendant in the Board.

03/01

The State Government vide Notification No. 2/1/2008-1Env. dated 15th January, 2021 notified the Haryana State Pollution Control Board (Group A, B, C and D) Service Regulations, 2021, wherein the following qualification for the post of Laboratory Attendant has been prescribed:-

"Matric with Science (Physics and Chemistry) having knowledge of Hindi or Sanskrit upto matric standard."

10 posts of Laboratory Attendant in FPL-2 Rs. 19900-63200 are sanctioned in the Board, out of which 02 posts are meant for direct recruitment and 08 posts are meant for promotion. Out of 10 posts of Laboratory Attendant, 02 posts meant for direct recruitment are vacant.

The Board had sent requisition to fill up 02 posts of Laboratory Attendants on 16.12.2022 to the Haryana Staff Selection Commission, as per the notified Service Regulations, 2021. However, the same has been referred back (Annexure 'A') with the remarks to make amendment as per Govt. letter no. 22/174/2022-3HR-III dated 11th Jan 2023 (Annexure 'B').

In view of the above observations of the Haryana Staff Selection Commission, amendment in Appendix-'B' of Haryana State Pollution Control Board (Group A, B, C and D) Service Regulations, 2021 is required and after the approval of the Board, the case will be sent to the State Government for amendment in the Service Regulations, 2021, as per section 12(3)(3A) of the Water (Prevention and Control of Pollution) Act, 1974, replacing the Matric word with 10+2, as under:-

"In the Haryana State Pollution Control Board (Group A, B, C & D) Service Regulations, 2021, in Appendix 'B' under column 3 against Sr. No. 34 for the word and figure "Matric", the figure and sign "10+2 with Science (Physics and Chemistry)" shall be substituted."

The relevant part of the Haryana State Pollution Control Board (Group A, B, C & D) Service Regulations, 2021 is at (Annexure-'C').

The matter is submitted to the Board for consideration and approval please.
