Subject: Amendment in Haryana Right to Information Rules, 2009.

I am directed to invite your kind attention to this department's Notification No. 5/52/2016-1AR dated 12.04.2021, which introduced a new Model Form "A" replacing the earlier version, as prescribed in "The Haryana Right to Information Rules, 2009". These amended rules herein called as "The Haryana Right to Information (Amendment) Rules, 2021" require RTI applicants to furnish proof of identity (such as Aadhar Card, Passport, Voter Card, Pan Card, PPP ID, or Government issued Identity Card) along with their application.

However, it has come to the State Government's attention, through the State Information Commission, that several public authorities in the State are not adhering to these rules diligently and some SPIOs (State Public Information Officers) continue to process RTI applications even when they lack accompanying proof of the applicant's identity. The State Government emphasises that neither the First Appellate Authority nor the SPIOs have the authority to waive the requirement for proof of identity. Such action on the part of First Appellate Authority/State Public Information Officer is subversive of spirit of rules and amounts to clear violation of the rules, which are not permitted by the Government.

It is therefore, requested that "The Haryana Right to Information (Amendment) Rules, 2021" should again be brought specifically to the notice of all First Appellate Authority/State Public Information Officer working under kind control of your respective offices and also made aware that any violation of ibid rules shall be viewed seriously. Copy of the Haryana Right to Information(Amendment) Rules, 2021 is enclosed.
