

3. That the unit will dispose off hazardous waste through authorized dealer.

4. That the unit will comply the order/ direction issued by the Hon'ble Supreme Court of India, Punjab & Haryana High Court, NGT, Environment Court or any other court. 5. That the unit will apply for renewal of authorization before 90 days from the expiry of this authorization. 6. That the unit will comply with the all the Rules/ Regulations/ Acts/ Notification issued by CPCB/ HSPCB and MOEF&CC.

7.In case, any violations found at any stage, then this authorization shall be revoked without giving any show cause notice and action will be initiated as per policy of the Board.

8. The unit will keep all the parameters within prescribed limits.

9.If any information and documents submitted is found to be false/misleading at any stage, Authorization under HWM will be revoked.

10. The earlier authorization granted HWU/KAI/2023/38088221 dated 09.08.2023 may be treated as null and void from the date of grant of this authorization.

11. Unit will follow the SOPs issued by CPCB and MoEFCC regarding Hazardous Waste

utilization as submitted by the unit.

12. Unit will provide vehicle details along with live tracking of the vehicles carrying Hazardous waste as per HOWM Rules, 2016 to the HSPCB and specific registered vehicles under Motor Vehicle Act should be used only; for the transportation of Hazardous waste.

#### Conditions of Authorization:

The authorised person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.

HARYANA STA

- The authorization or its renewal shall be produced for inspection at the request of an officer 2. authorised by the State Pollution Control Board.
- The person authorised shall not rent, lend, sell, transfer or otherwise transport the hazardous and other wastes except what is permitted through this authorization.
- Any unauthorised change is personnel equipment or working conditions as mentioned in the 4. application by the person authorised shall constitute a breach of this authorization.
- The person authorised shall implement Emergency Response Procedure (ERP) for which this 5. authorization is being granted considering all site specific possible scenarios such as spillages, leakages, fire etc. and their possible impacts and also carry out mock drill in this regard at regular interval of time.
- The person authorised shall comply with the provisions outlined in the Central Pollution Control 6. Board guidelines on "Implementing Liabilities for Environmental Damages due to Handling and Disposal of Hazardous Waste and Penalty".
- An application for the renewal of an authorization shall be made as laid down under these Rules. 7.
- Any other conditions for compliance as per the guidelines issued by the Ministry of Environment, 8. Forest and Climate Changes or Central Pollution Control Board from time to time.
- Annual return shall be filed by June 30 th for the period ensuring 31 st March of the year. 9.
- The hazardous and other waste which gets generated during recycling or reuse or recovery or pre-10 processing or utilisation of imported hazardous or other wastes shall be treated and disposed of as per specific condition of authorisation.
