## OFFICE ORDER

Regarding simplification of procedure for obtaining authorization under the Bio-Medical Waste Management Rules, 2016 by the healthcare facilities having bed capacity upto 20 beds/dental Chairs.

Whereas Ministry of Environment Forests and Climate Change, New Delhi vide notification No. G.S.R. 343(E) dated 28.03.2016 has notified Bio-Medical Waste Management Rules, 2018;

Whereas, as per Section 10 of the said Rules, each and every health care facility whether bedded or non- bedded is required to obtain authorization from the State Pollution Control Board and whereas the procedure for obtaining the authorization for healthcare facilities upto 20 beds/dental chairs, under the Biomedical Waste Rules, 2016 has been reviewed to simplify the same, it has been decided to adopt the following procedure:-

- The documents required to be submitted along with application for authorization under Bio-Medical Waste management Rules, 2016 for healthcare facilities upto 20 beds/dental chairs will be as under.
  - Location Plan/Google Location of HCF.
  - Copy of Agreement with CBWTF.
  - III. Self declaration as Annexure-I.
  - IV. Copy of Manifests of tifting of Waste by CBWTF operators for 07 days pertaining to previous one month.
- The authorization (fresh/renewal) under the Bio-Medical Waste Management Rules, 2016 applied by the healthcare facilities upto 20 beds/dental chairs will be granted by the concerned regional Office within

07 days of receipt of complete application without making inspection of those healthcare facilities. However, the concerned Regional Office shall ensure that no action is pending against the concerned heath care facility for violation of the Bio-Medical Waste Management Rules, 2016 Water (Prevention and Control of Pollution) Act, 1974, Air (Prevention (Protection) Act, 1986 and various rules made there under.

After grant of authorization, randomly selected 10% healthcare facilities 3. shall be visited by the Regional Offices as per inspection policy of the Board for checking compliance of the provisions of the Bio-Medical Waste management Rules, 2016.

This order shall come into force with immediate effect.
