## OFFICE ORDER

It has been brought to my notice that Construction and Demolition Waste is being dumped on the site of roads, green areas and ditches in Panchkula Town. In order to ensure effective Construction and Demolition Waste Management in the Municipal Corporation, Panchkula area, I Rajesh Jogpal, HCS, Commissioner, Municipal Corporation, Panchkula under Section 243 of Haryana Municipal Corporation Act, 1994 and other relevant laws hereby order to undertake these instructions:-

- (i) All Construction and Demolition Waste carrier owners who want to do this job are directed to get themselves registered with MCP. They shall display the registration number on the carrier painted with MCP logo in red color. Designated officer shall issue the certificate as per the enclosed performa after obtaining the documents of registration etc. A model application file is attached herewith. The principal originator of the Construction and Demolition Waste shall provide Construction and Demolition Waste to registered carrier only otherwise he shall be challaned with a fine of Rs. 5000/- (Rs. Five Thousands Only). All these works shall be completed within one month of notification and instructions and no Construction and Demolition Waste carrier shall be allowed to operate without registration thereafter. Carrier shall be confiscated found violating above instructions and owner/operator shall be fined with Rs. 5000/- This vehicle shall be released only after getting it registered with MCP at the first detection with 20% hike on subsequent detections. This Construction and Demolition Waste carrier shall be released only after getting it registered with MCP. This arrangement shall be reviewed after 6 months and if need be specific agencies may be hired for each zone to undertake this job.
- (ii) This order shall be enforced by Building Branch under the direct supervision of concerned Superintending Engineer. The Municipal Engineer shall be the Nodal Officer from Commissioner, Municipal Corporation, Panchkula. The concerned Building Inspector shall check with the h.o.p of Building Branch each and every carrier in respective areas and handover the copy of this order and shall note down the registration no. of carrier, name of owner and driver, their mobile no. and address and shall submit to XEN.
- (iii) Construction and Demolition Waste carrier owner should pay Rs. 205/- per ton for the segregated Construction and Demolition Waste and Rs. 565/- per ton for non segregated waste for the processing of the Construction and Demolition Waste at any designated site by the Corporation. The waste shall be processed and reused. Therefore, it shall help not only in keeping the city clean but also help to re-use this whole C & D Waste.
- (iv) MCP is also in process of identifying the transfer stations which shall be notified in due course of time.
- (v) The Construction and Demolition Waste carrier owner should follow the C & D Waste Rules of 2016 violation of which is punishable under sub-section (1) of Section 15 of the Environment (Protection) Act, 1986, i.e. in respect of each failure or contravention, be punishable with fine which may extend to one lakh rupees, or with both, and in the case of failure or contravention continuing, with additional fine which may extend to five thousand rupees for every day during which such failure or contravention continues after the conviction for the first such failure or contravention.
- (vi) The Construction and Demolition Waste carrier owner is not allowed to dump Construction and Demolition Waste anywhere else other than as per designated site by the MCP.

This order shall come into force with immediate effect.

Subject: Information required regarding Managing Construction & Demolition (C&D) waste as per C&D Waste Management Rule, 2016 in the city.

The 'Swachh Bharat' Mission under Ministry of Urban Development envisages processing of 100% Solid Waste generated in cities/Towns by 2<sup>nd</sup> Oct 2019, has a key objective which includes Construction & Demolition (C&D) waste. Unlike other rules addressing various key urban waste such as MSW, Plastic Waste, BMW, Construction & Demolition (C&D) waste, Solid waste Management Rules, 2016 are new rules that were notified on 29<sup>th</sup> March 2016 by the ministry Of Environment Forest and Climate Change(MoEF & CC).

As per rule 3 (C) "Construction & Demolition Waste" means waste comprising of building material,debris and rubble, resulting from construction ,remoulding, repair and demolition of any civil structure.

The Rules shall apply to every waste resulting from constructions, remoulding, repair and demolition of any construction of individual or organization or Authority who generates C & D Waste such as building material,debris and rubble.Waste also includes surplus and damaged products and material arising in the course of construction work of new flyover bridges ,under bridges, Jetties, terracotta, installation of new bottle/ telephone /Internet/Sewer Pipelines & Excavation/reconstruction of S- Fault/concrete Roads etc.

In view of facts narrative above, you are requested to provide the following information at the earliest as mentioned below:

1. Average Construction & Demolition (C&D) waste generated daily
2. Evidence C&D Waste from Bulk Waste Generators, generating >300 Ton C&D waste in a month, before giving sanction for construction
3. If Bulk Waste Generator is getting its C&D waste managed by the external agency/ contractor, copy of contract/agreement including payments made
4. List of C&D waste collection centers in the city - Log Book showing management of C&D waste as per prescribed rule
5. List of vehicles for managing C&D waste and penalty system in place for open dumping along with details of penalty/lites collected

Therefore, it is imperative that building and civil engineering department collect the data regarding C & D Waste generated on day to day basis and provide information as stated from sr. no. 1 to 5, to the Corporation, with in three days, by return email incpanchkula@gmail.com immediately since it is urgently required for Swachhata Sarvekshan 2019 which would further upgrade the status of Panchkula city.

This may be treated as most urgent.
