

## सार्वजनिक सूचना

माननीय सर्वोच्च न्यायालय द्वारा रिट याचिका (सिविल) संख्या 13029/1985 जिसका शीर्षक "एमसी मेहता बनाम भारत संघ और अन्य" है, में दिनांक 17.01.2025 को दिए गए आदेश के परिणामस्वरूप, हरियाणा सरकार के पर्यावरण, वन और वन्यजीव विभाग ने दिनांक 28.02.2025 को अपने अंतिम क्रमांक 16/09/2024-3Env. के माध्यम से आदेश दिया कि पूरे वर्ष हरियाणा राज्य के एनसीआर क्षेत्र में आने वाले जिलों में सभी प्रकार के पटाखों के निर्माण, भंडारण, बिक्री (ऑनलाइन मार्केटिंग प्लेटफॉर्म के माध्यम से डिलीवरी सहित) और फोड़ने पर पूर्ण प्रतिबंध रहेगा। माननीय सर्वोच्च न्यायालय ने दिनांक 06.05.2025 के अपने आदेश के माध्यम से निर्देश जारी किए हैं, जिसका प्रासंगिक भाग नीचे दिया गया है:-

"10. जैसा कि पहले कहा गया है, ये राज्य सरकारें न केवल पटाखों पर प्रतिबंध का सख्ती से कार्यान्वयन सुनिश्चित करेंगी, बल्कि इस न्यायालय के आदेशों के साथ-साथ पर्यावरण संरक्षण अधिनियम, 1986 की धारा 5 के तहत निर्देशों को लागू करने के लिए एक तंत्र भी बनाएंगी। ये राज्य एक शिकायत निवारण तंत्र बनाएंगे जो नागरिकों को पटाखों पर प्रतिबंध के बारे में निर्देशों के उल्लंघन के बारे में शिकायत करने में सक्षम बनाएगा।"

## PUBLIC NOTICE

Consequent upon order dated 17.01.2025 of Hon'ble Supreme Court of India in writ Petition(s) (Civil) No. 13029/1985 titled as "MC Mehta Vs Union of India & Others". Environment, Forest and Wildlife Department, Govt. of Haryana vide Endst No.16/09/2024-3Env.dated 28.02.2025 ordered that there shall be complete ban on manufacturing, storage, sale (including delivery through online marketing platforms) and bursting of all kind of firecracker in Districts falls in NCR Area in the State of Haryana throughout the year. Hon'ble Supreme court of India vide its order dated 06.05.2025 has issued directions, relevant part of which is reproduced below:-

***"10. As expressed earlier, these State Governments shall not only ensure strict implementation of the ban on firecrackers but must create a machinery to implement the orders of this Court as well as the directions under Section 5 of the Environment Protection Act, 1986. These States shall create a Grievance Redress Mechanism which will enable the citizens to complain about the violation of the directions regarding ban on firecrackers."***

Accordingly, the grievance redressal mechanism is created in each of the NCR districts by respective Deputy Commissioners, details of which are as under:-
