Guidelines for grant of registration under Plastic Waste (Management & Handling) Rules, 2011

1. The MoEF notified Plastic Rules, 2011 vide notification no.50-249(E) dated 4/2/11.
2. The SPCB shall be prescribed authority for enforcement of the provisions of these rules related to authorization, manufacture, recycle and disposal of plastic waste.
3. Rule-9 of PWM Rules, 2011 envisages that any person manufacturing or proposing to manufacture carry bags and multilayered plastic shall apply to SPCB for registration or for renewal in form 1 and recycler of plastic waste shall apply in form 2. The State Govt. of Haryana has completely banned the manufacture, distribution, stock, sale and usage of plastic carry bags. Hence the registration for manufacturer plastic carry bags can not be granted. However registration for multilayer plastic pouch/sachets is required under the rules.
4. SPCB shall not issue or renew registration for manufacturing or recycling unless unit has consent u/r Water/Air Acts and registration with GM DIC or any other agency authorized.
5. Registration shall be granted for 3 years.
6. Application for renewal shall be made at least 90 days before expiry of registration.
7. The industry shall reuse the plastic waste generated during the process or sell the plastic waste only to the plastic recycling units registered with Haryana State Pollution Control Board.
8. The industry shall not dispose the residue generated from recycling processes in the community dustbins provided for collection for Municipal Solid Waste.
9. The industry shall not supply plastic material / plastic rule to any manufacturer/ packing agencies / distributor/trader etc., to pack gutkha, tobacco & pan masala
10. The industry shall not use plastic material, in any form, in any package for packing gutkha, tobacco and pan masala in all forms.
11. The industry shall create awareness regarding proper management of plastic waste.
12. The industry shall not indulge in open burning of plastic waste.

Role of Regional Officer:-

1. Identification of Plastic manufacturing units in his jurisdiction.
2. Pursuing with multilayer plastic pouch manufacturing industries to apply for Consent to operate from the Board under Water & Air Acts and Registration of the Board under Plastic Waste (Management & Handling) Rules, 2011 at Regional Office.

3. Issuing / recommending for grant of Consent to Operate as per policy of the Board.
 4. Inspection of industry by the Regional Officer for checking the compliance of Plastic Waste (Management & Handling) rules, 2011.
 5. Forwarding the Registration application of the industry along with the detailed verification/ inspection report (as per format) and valid Consent to operate from the Board to Board Office for issuing Registration.
 6. The check list shall be adhered to strictly.

Unit is also complying under Water/ Air Act and also complying Plastic Waste Management Rules, 2011.

Therefore, the registration to the applicant is recommended and in case the applicant is non-complying the above mentioned stipulations then Regional Officer shall issue notice to the unit before sending case for rejection on the basis of the reply submitted by the applicant.
