Sub: Minutes of the meeting held under the chairmanship of Sh. Anurag Rastogi, IAS, Chief Secretary, Govt. of Haryana on 03.07.2025 at 03:00 PM in the Main Main Committee Room, 4th floor, Haryana, Civil Secretariat in OA No. 673 of 2018 in the matter of News item published in "The Hindu" authored by Shri Jacob Koshy titled "More river stretched are now critically polluted: CBCB-reviewing of Yamuna Action Plan.

At the outset, Chief Secretary welcomed all the participants.

The Chairman, HSPCB apprised that was as per communication that received from the Secretary, Department of Water Resources, Ministry of Jal Shakti, Govt. of India, meeting with the stake holder departments of State of Haryana was held on 27.05.2025, wherein, certain decisions regarding monitoring the water quality of the drains falling into river Yamuna, construction of new STPs, upgradation of existing STPs, construction of proposed STPs, construction of new CETPs, upgradation of existing CETPs, monitoring of ETPs of industries, checking the performance of STPs of Yamuna catchment area and capacity utilization of STPs were taken. Now, the meeting is being convened to review the action taken by the departments on the various activities with regard to control of pollution in river Yamuna.

DG, NMCG gave a brief presentation on various issues concerning to the cleaning of river Yamuna in Haryana. It was informed that out of 06 monitoring points of river Yamuna relating to the State of Haryana-3 points (Karnal, Panipat and Sonipat) are non compliant. Further, the presentation on the existing discharge of sewage of towns, capacity of existing STPs, capacity of utilization of STPs, status of ETPs of the individual industries, industries connected to CETPs, grossly polluting industries, water quality of drains of Haryana area falling into river Yamuna and further action plan to combat pollution in river Yamuna has been made.

Chairman, HSPCB detailed the action plan to control pollution in river Yamuna, w.r.t. point raised by the Director General, NMCG, for discussion in the meeting. These points are :

- i. Monitoring of Industrial activities through third-party inspection of GPIs (Timeline: March 2026) [by HSPCB/CPCB]
- ii. Upgradation on Non-Compliant 17 STPs in Yamuna Catchment in Haryana -

(Timeline: December 2026) [by PHED/ULBD, Haryana]

iii. Improving capacity utilization (current capacity utilization is only 60%)

(Timeline: April2026) [by PHED/ULBD, Haryana]

- iv. Creation of additional sewage treatment capacities (90 MLD in Gurugram and 227 MLDin Faridabad) -(Timeline: March 2028) [by GMDA, FMDA and ULBD]
- v. In situ treatment or I&D of 55 Sub-drains to the improve the water quality in 11 main drains impacting River Yamuna--(Timeline: March 2028) [by PHED/ULBD, Haryana]

Construction of 7 New CETPs of total capacity 125 MLD (Timeline: March 2028) [by HSIIDC/ULBD, Haryana]

In response to the points raised by NMCG, HSPCB, made a presentation on the following issues:-

A) Under construction STPs

- i. 2 STPs of capacity 2 MLD and 25 MLD being constructed by GMDA shall be completed by 31.12.2025
- ii. 1 STP of capacity 2 MLD being constructed by PHED for Khewra, Sonipat shall be completed by 30.06.2026.

B) Proposed STPs

- i. 4 STPs of capacity 340 MLD to be constructed by GMDA are at DPR/tendering stage for several years. 1 STP of capacity 45 MLD to be constructed at Badshahpur, Faridabad by FMDA is also at tendering stage.
- CEO, FMDA submitted that all these 5 STPs of capacity 385 MLD are likely to

be completed by 31.12.2027.

C) Proposed common effluent treatment plants (CETPs)

- O3 CETPs of capacity 90 MLD, DPR costing Rs. 824 cr. has been prepared and the same has been sent to NMCG for funding. Director General, NMCG clarified that NMCG cannot provide funds for construction of CETPs. Therefore, FMDA has to raise funds for construction of these 3 CEPTs as NMCG do not provide funds for CETPs.
- ii. No land is available for 2 CETPs of capacity 1.5 MLD and 9 MLD to be constructed at sector -18 and Sector-37, Gurugram

- iii. 01 CETP of capacity 20 MLD to be setup at sector 34, Gurugram, tender has been allotted for engaging consultant by HSIIDC.
- iv. For construction of 01 CETP of capacity 6 MLD at Kundli, Sonipat, no land is available. However, CETP is to be constructed by HSIIDC and DC greed to arrange to provide land.
- v. Work has been allotted for construction of 19.5 MLD CETP at Parwaloo, YamunaNagar.

After detailed deliberation, the following decisions were taken:-

- 1. All concerned departments are to submit monthly milestones for all project/ activities under the river action plans i.e. both Ghaggar as well as Yamuna and elsewhere.
- 2. PHED and ULBD shall submit the timelines for completion of upgradation work of 12 non compliant STPs in the format as mentioned in **Annexure-2**.
- 3. For construction of 04 STPs of capacity 100 MLD, 100 MLD and 40 MLD, the GMDA shall submit the timelines/ monthly milestones for completion of these STPs in the format as mentioned in **Annexure-3**.
- 4. For construction of 03 STPs of capacity 45 MLD, 20 MLD and 15 MLD to be constructed at Badshahpur and Mirzapur, the FMDA shall submit the timelines/ monthly milestones for completion of STPs in the format as mentioned in **Annexure-3**.
- 5. PHED shall submit the timelines/ monthly milestones for completion of 60 MLD capacity STP for Rohtak, in the format as mentioned in **Annexure-3**.
- 6. The funds shall be arranged by FMDA f or construction of 03 CETPs of capacity 50 MLD, 25 MLD and 15 MLD at Partapgarh, Mirzapur and Bashahpur. The CETPs shall be constructed and operated by HSIIDC. The FMDA shall put up the file separately for order in the matter. The HSIIDC shall submit the time lines/monthly milestones for completion of CETP in the format as mentioned in **Annexure-4**. The funds are to be arranged by GMDA.
- 7. The land shall be arranged by TCP Department for construction of 02 CETPs of capacity 1.5 MLD and 09 MLD for sector 18 and sector 37 in Gurugram. The HSIIDC shall submit the timelines/monthly milestones for completion of CETP in the format as mentioned in **Annexure-4**.

- 8. For construction of 06 MLD capacity CETP to be constructed at Kundli, Sonipat, land shall be arranged by DC/ SMDA and CETP shall be constructed and operated by HSIIDC. Timelines/ monthly milestones for completion 06 MLD CETP shall be submitted by HSIIDC in the format as mentioned in **Annexure-4**.
- 9. PHED shall submit the timelines/ monthly milestones for completion of 19.5 MLD CETP to be set up at Parwaloo, Yamuna Nagar in the format as mentioned in **Annexure-4**.
- Micro STP's are to be constructed by PHD and the funds for micro STPs in villages be arranged by PHED instead of D&P Department from State Govt.
- 11. Combined presentation on Yamuna action plan shall be prepared by NMCG and HSPCB and fortnightly meetings be held in this regard for YAP.
- 12. The status of all drains vis-a-vis insitu treatment shall be submitted to NMCG. The State has decided that all sewage to be treated in STPs instead of insitu treatment.

The meeting ended with vote of thanks to the chair and all the participants.
