- M/s E-Waste Recyclers India is having all authorization related e-waste dismantling from HSPCB and having all connects related to Air/Water/Hazardous waste. They have capacity of 667 MT per annum.
- Keeping in view our sales volume and generation of e-waste as per our future e-waste targets and our expansion plan we have decided to follow these mechanisms in our organization for collection of e-waste.

Our representatives explain them about process of disposal of e-waste and make them aware about nearest drop point. Our Recycler has collection arrangements to cover entire country for collection of E-waste. We have **Recycler Toll free no. 1800-102-5679** which can be approached by any consumer or bulk consumer for arranging collection of their e-waste by the agents of recycler or by the logistic support team of recycler for collecting E-wasting. **Our Recycler has agreement with transporter name M/s Om Logistics LTD. which can transport E-waste in safe and environmentally sound manner** from consumers/bulk consumers for environmentally sound dismantling and recycling at its facilities.

The Recycler has collection arrangements at large city hubs. These collection points will facilitate returns of e-waste by consumer / bulk consumers. In case of areas far away from Collection Points, a roving mechanism will be established, where in a mobile van shall be sent periodically to such areas so that customers can return their End of life (EOL) products for which announcement/publication of schedule of movement of roving vehicle and coverage of a particular area in a particular day at a particular time will be made through web sites and pamphlets in News Papers of that area where roving mechanism will be arranged.

Retailers employed by the Producers shall also form the forward line of collection of E-Waste (WEEE). They shall be useful for collection of products sold under exchange scheme. The Recycler shall collect the E-Waste (WEEE) directly from the Retailers on the information provided by us.

In very special cases customer shall also be provided the facility of courier services, wherein he will be directed to deposit his product directly with a registered transporter for onward delivery to the Recycling facility.

Purchase of E-Waste from open market M/s E-waste Recyclers India as a recycler knows the informal recycling market to meet shortfalls in target.

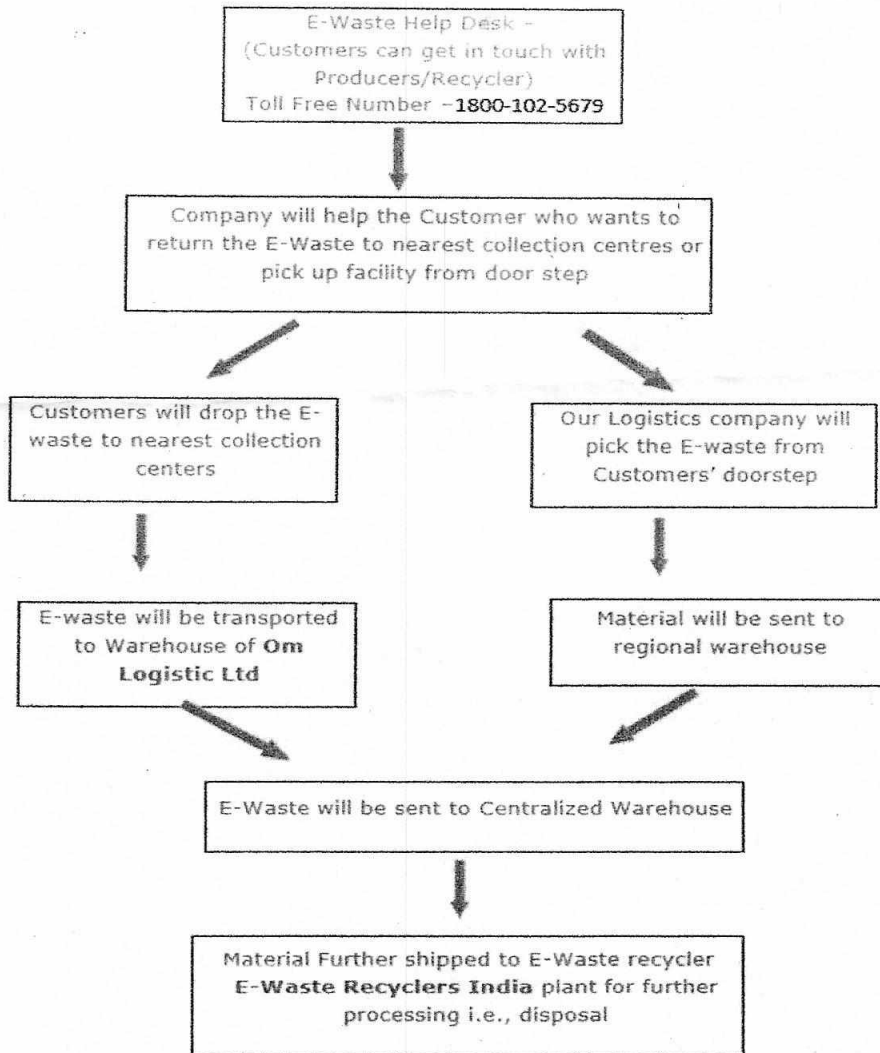
SAFE AND SECURE CHANNELIZATION FLOW CHART OF E-WASTE

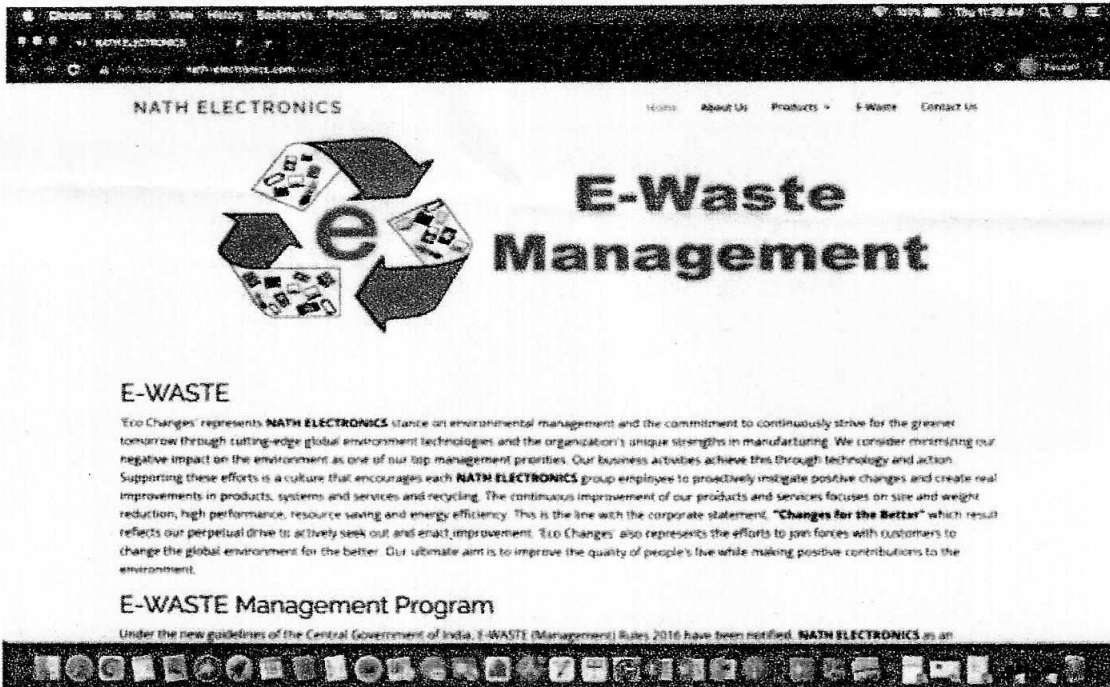

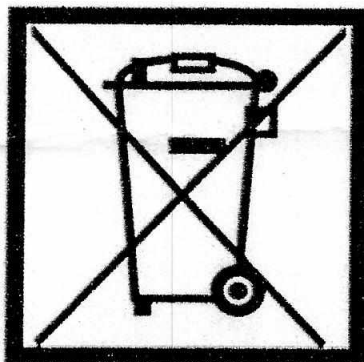

- Always look for information on the catalogue with your product for end-of life equipment handling
- Ensure that only Authorized Recyclers repair and handle your electronic products.
- Always call our E-waste Authorized Collection points to dispose products that have reached end-of life.
- Always drop your used electronic products batteries or any accessories when they reach the end of their life at your nearest Authorized E-waste Collection point.
- Always disconnect the battery from product and ensure any glass surface is protected against breakage.

Don'ts:

- Do not dismantle your electronic products on your own.
- Do not throw electronics in bins having "Do not Dispose" sign.
- Do not give e-waste to informal (Kabbadi) and unorganized sectors like Local Scrap Dealer Rag Pickers.
- Do not dispose your product in garbage bins along with municipal waste that ultimately reaches landfills.
