Office Order

Whereas, the Board in its 178th meeting held on 30.01.2018, vide agenda item no. 178.22 has approved the revised procedure for grant and refusal of consent to establish and consent to operate under Water Act, 1974 and Air Act, 1981 alongwith the list of industrial sectors/projects covered under Red, Orange, Green and White categories based upon the range of pollution index, for the purpose of consent management as per the revised criteria issued by the CPCB for the same through its modified directions issued under section 18 (1) (b) of Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 vide letter no. B29012/ESS(CPA)/2015-16/8571 dated 07.03.2016;

Whereas, the Board vide Head Office order Endst. No. HSPCB/2018/517-546 dated 26.02.2018 has issued consent procedure for grant of consent to establish and consent to operate under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 in supersession of earlier procedure issued vide Head Office order Endst. No. HSPCB/2014/10195-10218 dated 07.03.2014;

Whereas, the branch dealing with consent management of Ballabgarh Region in Head Office of the Board sought the clarification regarding categorization of "Atta Chakki", as same does not find mention under any of the categories of industrial sectors/projects categorized under Red, Orange, Green and White Category;

Whereas, the matter was examined by the committee constituted for categorization of industrial sectors/projects for consent management, in its meeting held on 01.09.2019 and based upon the recommendation of the committee, it has been decided that in the categorization of industrial sectors/projects issued vide order endst. No. HSPCB/2018/517-546 dated 26.02.2018, the industrial sector "Flour Mills (Dry Process)" at Sr. No. 20 under Green Category of industrial sectors/projects may be replaced with "Flour Mills/Atta Chakki (Dry Process) for commercial use (having wheat cleaning process and fugitive dust)" and Atta Chakki use for personal use with dry process without involving wheat cleaning process and fugitive dust emission may be added under White Category at Sr. No. 44;

Whereas, the above proposal regarding amendment in the category of industrial sector Flour Mills/Atta Chakki (Dry Process) was placed before the Board for consideration and approval in its 185th meeting vide agenda item no. 185.6 and the same has been approved by the Board with the partial amendment in the proposal that the Flour Mills/Atta Chakki running on commercial mode with packing facility of Atta for selling it into market (having wheat cleaning process and fugitive dust) will be included under Green Category for the purpose of Consent Management System.

In view of above and in partial modification in the categorization of industrial sectors/projects for consent management issued vide this office order Endst. No. HSPCB/PLG-135/2016/546-572 dated 14.07.2016 and vide order Endst. No. HSPCB/2018/517-546 dated 26.02.2018, it is hereby ordered that the industrial sector "Flour Mills (Dry Process)" at Sr. No. 20 under Green Category of industrial sectors/projects may be replaced with "Flour Mills/Atta Chakki (Dry Process) running on commercial mode with packing facility of Atta for selling it into market (having wheat cleaning process and fugitive dust)" and "Atta Chakki use for personal use with dry process without involving wheat cleaning process and fugitive dust emission" is added at Sr. No. 44 under White Category.

These orders shall come into force with immediate effect.
