

### PUBLIC NOTICE FOR REGISTRATION UNDER PWM RULES, 2016

As per provision, 9 (1&2) & 13(2) of PWM Rules, 2016, as amended 2018, "The producers, within a period of six months from the date of publication of these rules, shall work out modalities for waste collection system based on Extended Producers Responsibility (EPR) and involving State Urban Development Departments, either individually or collectively, through their own distribution channel or through the local body concerned"; and "Primary responsibility for collection of used multi-layered plastic sachet or pouches or packaging is of Producers, Importers and Brand Owners who introduce the products in the market. They need to establish a system for collecting back the plastic waste generated due to their products. This plan of collection to be submitted to the State Pollution Control Boards while applying for Consent to Establish or Operate or Renewal. The Brand Owners whose consent has been renewed before the notification of these rules shall submit such plan within one year from the date of notification of these rules and implement with two years thereafter."

In 2018, the PWM Rules was amended. Accordingly to provision 13(2) of PWM Rules, 2016 as amended 2018, "Every producer or brand-owner shall, for the purpose of registration or for renewal of registration, make an application in Form-I to:-

- (i) **The concerned State Pollution Control Board or Pollution Control Committee or the Union territory, if operating one or two States or Union territories: or**
- (ii) **The Central Pollution Control Board, if operating in more than two State or Union Territories",**

It has been observed that there are several Brand owners/producers/ manufacturers are operational without registration form HSPCB/CPCB, operating in non-conforming area and manufacturing the carry bags with thickness <50 micron.

Further, it has been also observed that a number of companies/firms are using plastics packaging's(MLP & Other Plastic) for packaging different items which fall under the category of Brand owner/producers have not registered their EPR Action Plan for disposal of MLP and other plastic waste till date.

Now, therefore, companies/firms using plastics packaging's(MLP & Other Plastic) for packaging different items which fall under the category of Brand owner/ producers/importer are hereby informed to submit their application with EPR action plan to the concerned regional offices of HSPCB and compliance thereof after involving Urban Local Bodies or other agencies at the earliest, failing which action as deemed fit under the relevant provisions of Environment (Protection) Act, 1986/ National Green Tribunal Act, 2010, will be initiated against defaulters.

Further all stakeholders departments/Agencies/Organizations and general public are advised identify the unregistered units, Plastic units operating in non-conforming area and units manufacturing carry bags with thickness <50 micron and provide the information to the regional office of concerned district or Head office of the Haryana State Pollution Control Board through hard copy or e-mail i.e [hspcb-solidwaste@gmail.com](mailto:hspcb-solidwaste@gmail.com).
