Notification

The 4th August, 1992

No. S.O.94/C.A. 1986/S. 5&7/92.—Whereas the Supreme Court on the 15th May, 1992, has ordered the closure/shifting of unlicensed stone crusher units in the areas of Delhi and Faridabad and shifting of others in the State of Haryana ;

And whereas, it is necessary and expedient to take immediate steps under sections 5 & 7 of the Environment (Protection) Act, 1986 and rules framed thereunder and in the light of the Supreme Court ruling dated the 15th May, 1992, to maintain ecological balance in the state, to prevent environmental degradation and to avoid traffic and human health hazards;

And whereas stone crusher units in the State of Haryana have been causing grave air pollution and causing hazards to traffic and human health;

And whereas the State Government has already taken a decision for making applicable to all stone crushers in Haryana the principles on the basis of which the decision was taken by the Supreme Court;

And whereas the State Government is of the opinion that in view of the grave injury to the environment it is not expedient to provide an opportunity to invite objections against the proposed direction as required under sub-rule (3) of rule 4 of the Environment (Protection) Rules, 1986, in view of the principles as laid down by Supreme Court judgement dated 15th May, 1992.

Now, therefore, in exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986, read with Government of India, Ministry of Environment and Forests, Department of Environment, Forests of Wild Life, Notification No. S.O. No. 152 (E) dated the 10th February, 1988, and in pursuance of the provisions of section 7 of the said act and rule 4 of the Environment (Protection) Rules, 1986, and with reference to Haryana Government, Environment Department notification No. S.O. 81/C.A.1936/S.5. & 7/92, dated the 9th June, 1992, the Governor of Haryana hereby identifies the Zones for stone crushers as given in column 2 of the Schedule given below comprising the areas as shown in Column 3 of the said Schedule.

All stone crushers which do not fulfill the siting parameters as stipulated in the Haryana Government, Environment Department, Notification No. S.O. 81/C.A. 1986/S. 5&7/92, dated the 9th June, 1992, shall be shifted to any one of the above identified zones by the 8th December, 1992. There shall be a maximum of 25

Closure will be ordered on the 9th December, 1992, of all stone crushers which do not fulfil the siting parameters as detailed in the said notification, dated the 9th June, 1992 :-
