Kindly refer to the subject noted above, In this connection it is intimated that in compliance of the directions issued by Hon'ble NGT on 23.04.2020 in the matter of OA No. 72/2020 titled as Scientific Disposal of Bio-Medical Waste arising out of COVID-19 treatment- Compliance of BMW Rules, 2016, CPCB has started the centralized tracking software application on mobile for tracking and data logging of specifically COVID-19 waste from the sources.

In view of above, it is requested to direct all HCFs /Quarantine centers/quarantine Homes/Sample testing centers/Laboratories/ULB generating the COVID Waste under your jurisdiction to get registered with the aforesaid mobile app of CPCB within 2 days so that data regarding COVID waste generated and treated in the State can be reported to CPCB on daily basis.
